The Salem County Art Tour's Holiday Artisans Show is an indoor event on the campus of the Salem County Career and Vocational Technical High School at 880 Route 45, Woodstown, NJ 08098. A food truck will be available at the show.

**JURYING PROCESS:** Jurors look for quality arts and crafts representing a wide variety of artistic focus. Work must be original, creative, handmade, reflect a unique vision, and be of consistent quality. The finished product must reflect a high level of skill. Fine artists may sell prints and printed merchandise of their original work. Absolutely no "craft kits" or manufacturer designed items will be accepted.

### **HOW TO APPLY: See application for submission options.**

Send to the Coordinator:

- -Completed application which includes contact information, space requested, a 250-word artist's statement which may include art career, experience, technical skill, media and techniques involved, what inspires you, and/or your vision.
- -Photos with **4-6 images** depicting all forms of your work that demonstrate the quality and best depiction of your craft.

**Plus, 1 image of your display** or a small mockup of how you propose to display your work. **Each image** needs to be named with your last name then first initial then a number (e.g., Jane Doe's first image would be DoeJ1.jpg etc.)

Note: Photos and portions of the artist statement may be used for show promotion.

**DEADLINE:** Applications, along with images, still being accepted **All Artists MUST jury each year.** Spaces will be based on entry postmark.

**JURY PROCESS & NOTIFICATION:** An impartial, knowledgeable team of jurors will consider each applicant's work. You will receive an email notification of your status approximately 3 weeks after applying.

If accepted, you may not change mediums or add categories that have not been juried. If you do, you will be asked to stop selling those items. The Jurying Committee reserves the right to request an artist remove items that are not up to the standards that were juried into the show.

### SPACE FEES: Due upon acceptance

6' Table - Postmarked within 10 days of acceptance-\$50; After 11-15 days of acceptance - \$60; 2 6' Tables - Postmarked within 10 days of acceptance-\$75; After 11-15 days of acceptance - \$85; 10x10 Booth - Postmarked within 10 days of acceptance-\$125; After 11-15 days of acceptance - \$140 Corner Booth - Postmarked within 10 days of acceptance-\$140; After 11-15 days of acceptance - \$165

**WAIT-LISTED**: If you have juried and been wait listed, you will be notified as soon as space is available. Space fee postmarked within 5 days of notification will be \$50; \$75; \$125 or \$140 respectively.

#### **RULES:**

- Your booth/table fee is your only fee. No commission or percentage is taken on sales. All exhibitors are responsible for collecting and submitting NJ State Sales Tax on their sales.
- -Each exhibitor space will be marked and assigned by the set-up committee. Exhibitors must provide their own booth structures, hanging equipment, electrical cords, and furnishings (tables, racks, chairs, etc.). ALL tables must be draped/covered to the floor. The room is well lit. Tables and electric outlets are available on a limited basis. Exhibitors are solely responsible for the safety of their exhibit.
- During set-up hours, please unload as quickly as possible and move your vehicle to allow others access. During show hours vendor vehicles are not permitted in the center parking area.
- -The show supporters, committee, Salem County Career and Vocational Technical High School or Salem County Art Tour are **NOT** responsible for any losses or damage and assume no responsibility whatsoever.
